**The following terms and conditions apply; please read carefully and initial each term:**

### Tuition Terms and Conditions

1. \_\_\_\_\_ A \$50, *non-refundable*, one-time registration fee must be paid to reserve my child's spot at Learning Moore Through Nature & Play (LMTNP).
2. \_\_\_\_\_ Tuition payments must be paid in full through Venmo (Olivia Moore, @Olivia-Moore-107) by the Sunday before the care week begins.
3. \_\_\_\_\_ Venmo payments are labeled as follows: Child's Name - week of month/mon-fri  
ex. Janae Williams - week of 2/2-6      or      Nico Voll - week of 3/30-4/3

4. \_\_\_\_\_ Tuition is non-refundable and due in full every Sunday regardless of attendance, scheduled school closures, or emergency closings.
5. \_\_\_\_\_ I have viewed the list of yearly scheduled school closures; I can also view it on the LMTNP website.
6. \_\_\_\_\_ LMTNP requires a two-week notice to cancel the Agreement above.

## Program Terms and Conditions

1. \_\_\_\_\_ I **MUST** submit all fully completed required forms and records before my child can begin care: Agreement form, Child Health Record, child's immunization record and/or medical or religious exemption statement, Emergency Contact/Parental Consent form, Influenza Immunization form, Emergency Plan form, Topical Products form, and others indicated by LMTNP staff.
2. \_\_\_\_\_ LMTNP occasionally uses photographs on the website, Facebook, other marketing materials, and in child/family projects. By signing my initials, **I give permission for photographs of my child and/or family members to be used in these and similar ways**. If I do not wish my child's photograph to be used, I will provide a separate written notice outlining my wishes.
3. \_\_\_\_\_ LMTNP makes independent determinations for inclement weather announcements. If weather circumstances arise that require program delay or cancellation, LMTNP staff will contact families directly.
4. \_\_\_\_\_ If my child becomes ill during the day, I will be called to pick up my child as soon as possible. LMTNP staff cannot administer medications.
5. \_\_\_\_\_ Only authorized persons will be allowed to pick up my child. Children will not be released to anyone else without written authorization. I am responsible for keeping an up-to-date list of authorized persons.
6. \_\_\_\_\_ I agree to prioritize the health and safety of the children, families, and staff by keeping my child home when there are any signs of illness (fever over 100F, vomiting, diarrhea, etc) and erring on the side of caution.
7. \_\_\_\_\_ Children learn best in an environment that values clear communication. I agree to bring any concerns, questions, and issues to LMTNP staff, and model communication and conflict resolution to solve problems collaboratively.
